## GENERAL INFORMATION

The Nebraska Child Support Payment Center is the processing center for all Nebraska child support payments. The payments must be made electronically, by mail, at their walk-up payment window at 421 South 9th Street, Suite 137 Lincoln, NE, or at a PayNearMe location.

The payments can be in the form of personal check, credit card, money order, cashier's check or electronic check, as well as cash (walk-in payment or PayNearMe location only).

Payment coupons will be provided to the payor and billing statements will be mailed each month. The statement will show the balance due for each month.

All payments must include a payment coupon or include the name of payor, Social Security number, county, court case number and name of payee.

## WHO DOES WHAT?

### Child support enforcement:

The Child Support Enforcement Program helps children obtain financial support from both parents, enables current public assistance recipients to end their reliance on welfare, and can help prevent single parents from entering public assistance.

### Child support payment center:

Was established so that there is one location where all child support payments are received.

We recommend that you periodically check the records to make sure they accurately reflect the current status of your account. You can obtain this information by calling the Child Support Enforcement office or by obtaining a password and accessing the information online at:

## PAYMENTS

Payments for court ordered child care, court costs, fines, attorney fees, alimony (not in connection with a child support order), maintenance support, property settlement, and judgments are made to the Clerk of the District Court in the county which has jurisdiction over your case. In **Lancaster** County, the address is:

### PAST DUE CHILD SUPPORT

If your child support payments are past due, the Child Support Enforcement office has several methods to collect past due obligations. They will assist in the collection if the child support is 30 days past due or more. Contact them at: 402-441-8715.

## How is child support determined?

The Nebraska Child Support Guidelines (a mathematical calculation) were developed by the Nebraska Supreme Court to determine the responsibility of both parents to contribute to the support of their children in proportion to their respective net incomes.
